VENDOR INFORMATION & RESPONSIBILITIES

Selling / PA State Sales Tax Selling is permitted within vendor booths. Vendors are responsible for applicable state tax regulations. Vendors acknowledge and accept full and total responsibility for any and all business, privilege, amusement or other taxes which may be due under state, federal or local law as a result of their participation in Opus One's RenFaire event.

Vendor Personnel No more than three vendor attendants will be granted access to the event space. An attendant must be present during the event hours. Neighbors share this responsibility during a representative's brief absence. If a vendor space is not occupied by 1:45pm on the day of the event, the space may be reassigned or used for another purpose (no refund). Vendor representatives who encounter emergency delays should inform Opus One by phone or email. Opus One: Berks Chamber Choir is not liable for any accident or illness that occurs as a result of participation in the RenFaire event.

Set Up / Tear Down All materials must be removed by the end of the pre-arranged tear down period. Vendors will be financially responsible for the removal of any remaining items.

Restrictions / Objectional Material / Persons No pets are allowed on the grounds. No alcoholic beverages are allowed on the grounds. No Smoking is permitted on the grounds. Vendors will comply with any and all fire regulations set by St. John's Hain's Church. Opus One reserves the right to censure any vendor exhibit which may be in violation of these policies, or may be objectionable, detracting from the general character of the event, and if not corrected, reserves the right to prohibit or evict vendors. Opus One reserves the right to eject any objectionable person/persons from the event space. Said exhibit, person, persons, hereby hold Opus One harmless from, and waive any right, and/or claim for damage arising from said ejection. In the event of restriction, eviction, or ejection, Opus One is not liable for refunds or other expenses.

Use of Space Distribution of promotional material, demonstrational/promotional activity, and the selling of any and all products is permitted only within the space assigned the vendor. No firm, organization or school sales representatives are permitted to solicit business within the exhibit area (meaning those who have not purchased space). No vendor shall share space allocated without the knowledge and consent of Opus One. No vendor shall obtain space outside the designated area or move part of the display to another location. Vendor exhibits shall not be expanded in any way, front, side or back. Displays shall not be placed in such a manner as to interfere with other vendors and must not block walking paths.
